

The appointment letter details the proposed position, salary, benefits, privacy policy, work policy, start date, and important employment information. The candidate usually receives an appointment letter on the first day after starting work and returns the signed copy to the employer indicating the acceptance of the appointment letter. This appointment letter format can be used by the Company's HR manager or the Company Manager offering the job to a potential hire. This appointment is an appointment puts officially and in writing everything else that still remains unspoken during work, fills in the gaps and connects the dots about any issues or details the employee may still have and gives him a feel about the day-to-day work and daily responsibility expected of him. Appointment letters are printed on employer forms and prepared by a management or HR manager authorized to hire a candidate. If a candidate agrees to the position, the candidate must sign a copy of the letter and return it to the employer to indicate employment, after which the contractual obligation to be fulfilled by both parties has become mandatory.
